

Developing Solutions® Software End User License Agreement

This **Developing Solutions** Software End User License Agreement ("Agreement") is a legal agreement between you and Developing Solutions Inc., its subsidiaries, affiliates, successors and assigns (collectively, "Developing Solutions Inc.") for the application software developed and distributed by Developing Solutions, Inc. (collectively, "Software"). By requesting a license for the Software, or using the Software, you are binding yourself and, if applicable, the business entity that you represent (you and, if applicable, such entity, collectively "Licensee") to the terms and conditions of this Agreement. If Licensee does not agree to be bound by the terms of this Agreement, Licensee may not use, install, or activate the Software in any way and must delete all copies of the Software from its computer systems.

1. Grant of License

(a) License Grant. Subject to the terms, conditions and restrictions in this Agreement, Developing Solutions Inc. grants to Licensee a limited, revocable, non-exclusive, non-transferable, (except as otherwise permitted in this Agreement), and non-sublicenseable license to (i) use the Software, in object code form only, for its internal purposes as an end user and (ii) use the provided documentation and/or specifications, whether printed, on-line or electronic (the "Documentation"), in support of Licensee's permitted use of the Software. Developing Solutions Inc. reserves all rights not expressly granted herein and Licensee will acquire no such rights, whether by estoppel, operation of law, or otherwise.

(b) Licensed Capability. The Software contains many features and functions which are activated by a license file. Licensee acknowledges that the grant of license to use the Software is limited to only those quantities, features and capabilities which were intentionally activated in the license file provided by Developing Solutions Inc. Licensee acknowledges that it has NO LICENSE to use quantities, features or functions which are not enabled in the provided license file. Licensee acknowledges that Developing Solutions Inc. is only obligated to provide a license file which enables features specifically itemized in an order which has been paid, independent of whether the feature was enabled in a previous license file.

(c) License Duration. The Licensee acknowledges the licenses may expire based on the terms under which the license was granted as follows:

Temporary Licenses: For leased temporary licenses, while in compliance with this license and in good standing with Developing Solutions invoices, a series of expiring licenses will be issued and until the temporary period defined in the paid invoice. The Licensee acknowledges the expiration date in the invoice is correct by paying it and installing the license file and agrees to make no attempt to use the capabilities beyond the date in the file.

Purchased Licenses: For purchased licenses, while in compliance with this license and in good standing with Developing Solutions invoices, a series of expiring licenses will be issued and renewed. The Licensee may move the license to new hardware before receiving their next expiring license once per twelve (12) month period, by requesting a new license be issued. The expiration date of the license will be at the sole discretion of Developing Solutions Inc. and independent of any date in previous license files.

(d) Licensed System. There are two licensing models supported for the Software. Floating and Node Locked, with the normal legacy model being node locked. In all cases there is a Node Locked license, however in the floating model, the License Server is node locked, while the Software executable may float. In the Node Locked model, the Software executable is Node Locked. Node Locked means that a software executable is licensed to run on one, and only one, computer system and that only one copy is permitted to run on that system. The system to which software is node locked is identified by the SystemID file provided when requesting a license, and the Licensee shall not attempt to circumvent the node locking function, and shall not run (or attempt to run) Node Locked licenses on any other computer other than the one identified by the original SystemID file, including virtual machines.

(e) The Licensee acknowledges discontinuance of Software Maintenance results in acceptance of the Software as is and Developing Solutions, Inc. will not provide software updates of any kind when not under maintenance.

(f) The Licensee may request a permanent (non-expiring) license by signing the Developing Solutions Permanent License Acknowledgment. The Licensee forfeits their privilege to move the permanent license to new hardware without paying a fee.

(g) Illicit Code. Developing Solutions Inc. warrants that Software provided to Licensee by Developing Solutions Inc. shall not be designed to (a) replicate, transmit or activate themselves without control of a person operating computing equipment on which they reside except as described in the Software documentation; (b) alter, damage or erase any data or computer programs without control of a person operating computing equipment on which they reside except as described in the Software documentation. This provision does not apply to Developing Solutions Inc. license keys or passwords necessary for the operation of the Software (if any) which are provided for the provisioning of license keys.

(h) Order of precedence. In the event of any inconsistencies between this Agreement and any quotes, purchase orders or terms on a web site referenced or incorporated therein, terms offered in valid quotes will take precedence, followed by this Agreement and its incorporated attachments.

(i) Updates. If Developing Solutions Inc. provides Licensee with any revised, modified or replacement Software, or additional or supplemental Software, or any updates, releases, error correction, or bug fixes related to the Software, the same shall become part of the "Software" licensed hereunder when delivered to Licensee and shall be subject to all of the terms and conditions contained herein. Licensee acknowledges that the acceptance and use of any such update constitutes acceptance of any modification to this License included in the update, or the then current License. Licensee acknowledges and agrees that this license does not grant rights to any updates or impose any obligation on Developing Solutions to provide updates to the Software. With respect to any technical information Licensee provides to Developing Solutions Inc. in connection with the license granted to Licensee hereunder, Developing Solutions Inc. and its distributors may use such information for any purpose without restriction, including, without limitation, for product support and development.

2. Title; Rights

(a) Ownership. Licensee acknowledges and agrees that Developing Solutions Inc. and/or its affiliates, licensors and/or suppliers (as applicable) own all rights, title and interest in and to the Software (including, without limitation, any copies, extracts or associated media thereof and any images, applets, photographs, animations, video, audio and/or text incorporated into the Software), as well as all patents, trademarks, trade names, inventions, copyrights, know-how and trade secrets, and any related applications or extensions, relating to the design, manufacture, operation or service of the Software.

(b) Copyright. Without limitation of Developing Solutions Inc.'s other rights, Licensee acknowledges and agrees that the Software is protected by copyright laws and international treaty provisions.

(c) Licensed Not Sold. Licensee acknowledges and agrees the Software has been licensed to Licensee pursuant to the terms and conditions of this Agreement and that the Software has not been sold to Licensee.

3. Restrictions and Limitations

(a) General Restrictions. Licensee shall not use, copy, merge or transfer copies of the Software or the Documentation except as may be expressly and specifically authorized in this Agreement. Licensee may not, under any circumstances, reverse engineer, decompile, disassemble or otherwise attempt to discover the source code of the Software. Licensee may not attempt to reverse engineer, decode, or decrypt the license file, or provide any information or assistance to any other person or organization attempting to do such. Licensee may not, and agrees that it will not, transfer, assign, rent, lease, lend, resell or in any way distribute or transfer any rights in this Agreement or the Software to third parties, including (without limitation) by operation of law, except as explicitly allowed in this Agreement, without Developing Solutions Inc.'s prior written approval and subject to written agreement by the recipient to the terms of this Agreement.

(b) Export Restrictions; Compliance with Laws. Licensee agrees that Licensee will not, directly or indirectly, export or transmit the Software to any country to which such export or transmission is restricted by any applicable U.S. regulation or statute, without the prior written consent, if required, of the Bureau of Export Administration of the U.S. Department of Commerce or such other governmental entity as may have jurisdiction over such export or transmission. Licensee agrees to comply with and conform to all applicable laws, regulations, ordinances and executive orders relating to Licensee's use of the Software.

4. Assignment

Notwithstanding anything to the contrary, either party may assign or transfer this Agreement and any or all rights granted in this Agreement to any third party in its entirety in the event of a merger with or into, or a transfer of all or substantially all of the party's assets to a third party who assumes all of the party's liabilities and obligations under the Agreement.

5. Mergers and Acquisitions

Notwithstanding anything to the contrary, in the event Licensee acquires another entity or is acquired by another entity (a merger or acquisition), Licensee may use any or all rights granted in this Agreement for the benefit of the acquired or merged entity except as otherwise stated in the Agreement, for no additional fee.

6. Use Audit

Developing Solutions Inc. shall have the right to collect data or to conduct or direct (or both) an independent accounting firm to conduct, upon reasonable notice, during normal business hours on Licensee's premises under Licensee's supervision, an audit to verify Licensee's compliance with the terms and conditions of this Agreement.

7. Term and Termination

(a) General. This Agreement and the license(s) granted herein will remain effective until terminated. Licensee may terminate

this Agreement and the license(s) granted herein by ceasing use of the Software and any related Documentation. The license(s) granted to Licensee under this Agreement will also automatically terminate upon the expiration of the applicable leased license term, if any, or if Licensee fails to comply with any term or condition of this Agreement.

(b) Licensee Obligations Upon Termination. Licensee agrees, upon any termination of this Agreement, to cease use of and to destroy or return to Developing Solutions Inc., all copies of the Software and any related Documentation.

8.Warranty

For a period of 30 days following delivery of the Software to Licensee ("Warranty Period"), Developing Solutions Inc. warrants that the Software shall perform in all material respects according to the Documentation when used with the approved computer equipment. In the event of any breach or alleged breach of this warranty, Licensee shall promptly notify Developing Solutions Inc. Developing Solutions Inc. shall at its sole discretion determine whether the Software is performing according to the Documentation, and if not, shall (1) choose to correct the Software and/or Documentation within a reasonable period of time so that it operates according to the Documentation or (2) terminate the this agreement and refund Licensee's cost actually paid to Developing Solutions Inc. This warranty only provides Licensee resolution of reported issues, and does not constitute Software Maintenance. Developing Solutions Inc. at its sole discretion may include other corrections/enhancements within the Software and/or Documentation, in addition to any correction for reported issues. This warranty shall not apply to the Software if used improperly or in an operating environment not approved by Developing Solutions Inc.

Beyond the specific functional warranty in the previous paragraph, after the expiration of the Warranty Period, and to the maximum extent permitted by applicable law, Developing Solutions Inc. and its suppliers, licensors and distributors do not make and specifically disclaim, all express and implied warranties of every kind relating to the software and/or use of the software (including, without limitation, actual and implied warranties of merchantability, title, fitness for a particular purpose, and non-infringement), as well as any warranties that the software (or any elements thereof) will achieve a particular result, or will be uninterrupted or error-free.

9.Software Maintenance

This license does not include any Software Maintenance. Software Maintenance is defined as any new, corrected or enhanced version of the Software as created by Developing Solutions Inc. Such enhancement shall include all modifications to the Software which Licensee has the right to use as defined in this Agreement. These modifications may provide such things as improved performance, ease of use, and additional features within the licensed functionality (e.g. what a new Licensee would be licensed upon licensing the same capabilities).

10.Limitation Of Liability; Disclaimer

(a) Limitation of Liability. To the maximum extent permitted by applicable law, in no event shall Developing Solutions Inc., its suppliers, licensors or distributors be liable under any theory of liability for any consequential, indirect, incidental, special, punitive or exemplary damages of any kind, including, without limitation, damages arising from loss of profits, revenue, data or use, or from interrupted communications or damaged data, or from any defect or error or in connection with Licensee's acquisition of substitute goods or services or malfunction of the Software, or any such damages arising from breach of contract or warranty or from negligence or strict liability, even if Developing Solutions Inc.. or any other person has been advised or should know of the possibility of such damages. Developing Solutions Inc.'s and its distributors' aggregate sole liability for any damages to Licensee or any other person or entity shall not exceed the price actually paid for the license to use the Software, regardless of any form of the claim.

(b) Additional Statements. Additional statements by agents, licensees, employees, resellers or distributors of Developing Solutions Inc.. do not constitute warranties by Developing Solutions Inc., do not bind Developing Solutions Inc., and may not be relied upon.

(c) Responsibilities of Licensee. As a licensee of the Software, Licensee is solely responsible for the proper installation and operation of the Software in accordance with the instructions and specifications set forth in the Documentation. Developing Solutions Inc. and its distributors shall have no responsibility or liability to Licensee for improper installation or operation of the Software.

(d) Failure of essential purpose. The terms of this section will apply notwithstanding the failure of any remedy to achieve its essential purpose.

(e) State Law Rights. Licensee may have other rights which may vary from state to state or in other jurisdictions. Because some states or jurisdictions may not allow limitations on the duration of implied warranties, or limitations on or exclusions of consequential or incidental damages, some of the above limitations may not apply to Licensee depending on its state of residence. Licensee should seek independent legal advice regarding such rights.

11. Indemnity

Licensee hereby agrees to indemnify, protect, defend and hold Developing Solutions Inc. and its distributors harmless from and against any and all claims, losses and damages, including without limitation, reasonable attorneys' and experts' fees and disbursements, (a) which may at any time be asserted against Developing Solutions Inc. or its distributors by any party for Licensee's failure to perform any of the covenants, agreements, terms, provisions or conditions contained in this Agreement, (b) by any party by reason of Licensee's use or misuse of the Product, or (c) resulting from any failure by Licensee to comply with any term, condition or restriction in this Agreement.

12. Non-Disclosure

Licensee shall take all reasonable steps necessary to ensure that the Software, and any related Developing Solutions Inc. information, or any portion thereof, is not made available or disclosed by Licensee (or by any of its employees, representatives or agents) to any person other than as may be necessary to Licensee's employees, representatives and agents to use the same as expressly permitted herein. Licensee agrees that all of its employees, representatives and agents having access to the Software shall observe and perform the terms of this Section. Licensee shall not provide the Software or license file, its accompanying Documentation or the technical data to any party, unless such third party accepts the same restrictions as are set forth in this Section. Licensee is responsible for ensuring proper notice is given to all such third parties and the Software, its accompanying Documentation and the technical data are properly marked with the required legends.

13. Governing Law

This Agreement and the rights and obligations of the parties hereunder shall be governed by the laws of the State of Texas, without reference to conflicts of laws principles provided, however, that if the Software was acquired outside the State of Texas, then certain local laws may apply. The parties agree to the non-exclusive jurisdiction of the state and federal courts in Dallas County, Texas in connection with the litigation of any dispute under this Agreement and waive any objection to such jurisdiction based on venue or personal jurisdiction. In addition, this Agreement will not be governed or interpreted in any way by referring to any law based on the Uniform Computer Information Transactions Act (UCITA), even if that law has been adopted in Texas, and the United Nations Convention on Contracts for the International Sale of Goods is hereby excluded.

14. Miscellaneous

This Agreement sets forth the entire agreement between Developing Solutions Inc. and Licensee with respect to the Software and Licensee's use thereof. No provision of this Agreement may be waived, modified or superseded except by a written instrument signed by each of Developing Solutions Inc. and Licensee. Developing Solutions Inc. may provide translations of this Agreement to its users as a convenience. However, this Agreement was drafted in English and the parties agree that the English-language version of this Agreement governs in the event of any conflict or inconsistency between the English-language version and any translations thereof. Any suppliers, licensors and distributors of Developing Solutions Inc. shall be direct and intended third-party beneficiaries of this Agreement, including without limitation the disclaimers of warranties and limitations on liability set forth herein. No failure or delay in exercising any right or remedy shall operate as a waiver of any such (or any other) right or remedy. The language of this Agreement shall be construed as a whole, according to its fair meaning and intent, and not strictly for or against either party, regardless of who drafted or was principally responsible for drafting this Agreement or any specific term or conditions hereof. This Agreement shall bind and inure to the benefit of the parties and their successors and permitted assigns. Both parties are acting as independent contractors with respect to the activities hereunder. In the event of any legal proceeding between the parties arising out of or related to this Agreement, the prevailing party shall be entitled to recover, in addition to any other relief awarded or granted, its costs and expenses (including reasonable attorneys' and expert witness' fees) incurred in any such proceeding. If any provision in this Agreement is invalid or unenforceable, such provision shall be construed, limited or altered, as necessary, to eliminate the invalidity or unenforceability and all other provisions of this Agreement shall remain in effect.
